Minutes of the Meeting of the Parish Council at 7.30 pm on Friday 4th October 2019 in Parbold WI Hall.

Present: Cllr Arnold (Chairman), Cllr Blake, Cllr Bithell (Vice Chairman), Cllr Schaffel, Cllr Quirk.

1. To record apologies for absence

Apologies were accepted from Cllr Butts, Cllr Carruthers, Cllr Gill, Cllr Holland, Cllr Stopford.

2. To receive declarations of interest

None declared.

3. To sign as a correct record the minutes of the meeting held 6th September 2019

The minutes were accepted as a correct record of the meeting and duly signed by the Chairman.

4. Public Participation: The meeting will be adjourned for an appropriate time (four minutes maximum per speech) for members of the public to raise matters of concern or interest as notified to the Chairman.

Residents of Greenfield Avenue whose property backs onto the village hall play area attended to explain the issues they were having with antisocial behaviour in the play area. They thanked the Parish Council for taking their concerns seriously and viewing the cctv and added thanks also to PC Gordon Davies, who had visited them. They will continue to log events with the parish council and will contact police if they feel it necessary to do so. It was suggested that PC Gordon Davies view the cctv footage and be asked if any further action ought to be taken.

5. Update on engagement problems with Hoscar Sewage Works (Wigan Waste Water Treatment Centre)

The proposed meeting with UU at Hoscar was cancelled at their request. The new date is Tuesday 29th October at 9am-10am. Cllr Stopford and Cllr Holland have expressed a willingness to attend. Cllr Arnold and Cllr Quirk will attend.

# 6. To reiterate the rules covering donations under Section 137 of the Local Government Act 1972 and update Standing Orders if required

- For information: A Parish Council, in accordance with its powers under section 137 Local Government Act 1972, may incur expenditure which, in the opinion of the Council, is in the interests of the area or its inhabitants and will benefit them in a manner commensurate with the expenditure
- Section 137A, Financial assistance to be conditional on provision of information...the organisation, body or fund.... furnish the authority a statement in writing of the use to which that amount has been put.

The legislation adds [at Section 137A.(4)] It shall be a sufficient compliance with a requirement imposed ...... that there is furnished to the local authority concerned an annual report or accounts which contain the information required to be in the stated. And at Section (5) A statement (or any report or accounts) provided to a local authority in pursuance of such a requirement shall be deposited with the proper officer of the authority.

To comply with the above, [and for Parbold Parish Council (as the local authority concerned) to prove that such enquiries have been made before the issue of public money to any cause], the Clerk (as proper officer of the authority) must receive the request in writing with a list of residents supporting the issue and accounts for that organisation in order for the request to be put to the Parish Council.

# 7. Update on Application LCC/2019/0028 - Parbold Hill and consider request for funding from Stop Parbold Hill Landfill group

The meeting noted the email from a member of Stop Parbold Hill Landfill group, explaining that the next stage may require more funding to seek expert opinion but that at this stage the Environment Agency had halted the planning application, by requiring that a permit application be submitted. The Clerk was asked to reply to the email offering support should a formal application be submitted.

#### 8. Problem of flooding of railway subway beneath the Station Road

Responses from Network Rail suggest the problem is due to development that a resident has done which has blocked the drain. Network Rail claim they are not able to access the property and the matter is with their solicitors. Rosie Cooper MP had responded that she had directed questions to Mr Stephen Young, Executive Director of Growth, Environment & Transport at Lancashire County Council.

It was resolved to write to Health & Safety Executive to seek an opinion, as the flooding of this subway is endangering life. Complaints have been received over the last four years and the situated has worsened over this period. The station is very busy with trains every twenty minutes during the day and a more than average pedestrian crossing rate, because it cuts the village and amenities in half, with businesses on either side. People are tempted to run across the lines whilst the barriers are down because the subway is knee-high in water. It is high enough that a small child could drown. We have witnessed rail passengers running across the railway line to reach their train as it is in the station. We feel there is a serious risk to life.

It was resolved to continue enquiries with all agencies and pursue lobbying those reqponsible for this area.

There were no comments on the proposals to remove the low-use public phone boxes on the list. It was resolved to use the address on the consultation to find out if any red telephone boxes were available for purchase.

# 10. To confirm arrangements for Remembrance Sunday, the purchase of two wreaths with an additional donation to The Poppy Appeal

It was resolved to pay £100 to the Royal British Legion - comprising £32 for the purchase of two wreaths and £68 donation to the Poppy Appeal. Cllr May Blake will present one at Our Lady & All Saints RC Church and Cllr Brian Arnold will present one at Christ Church, Parbold-in-Douglas.

#### 11. To consider a donation to Parbold Unlimited for Christmas street lighting

No application was received.

# 12. To consider a contribution towards the costs of Parbold WI to assist with costs of lighting the Christmas Tree

It was resolved to pay £50 to the Parbold Women's Institution to contribute towards their higher electricity costs over the Christmas period, due to lighting the village Christmas Tree.

#### 14. Village Hall Issues:-

#### • Consider issue of external lighting at the Village Hall

The Chairman had met with the electrician who claimed the lights were being triggered by movement and not at fault. Although reports from PCA were that one light had water ingress, short-circuiting the lights. Bunting has been left up at the hall following the street festival and movement of the bunting will trigger the lights to come on.
