Application Number: 2022/0297/FUL

Proposal: Variation of conditions no 2 and 3 imposed on planning permission 2015/0441/COU relating to approved drawings/parking provision.

(Resubmission of refused application 2021/0962/FUL)

Location: 8 Station Road, Parbold, Wigan, Lancashire, WN8 7NU

The Parish Council object to this application and support the comments of the WLBC Conservation Officer. This wall is sited within the Mill Lane conservation area and the Council agreed that the traditional features and historic character should be preserved wherever possible.

Application Number: 2022/0081/ADV

Proposal: Display of signage: 3no. illuminated logo signs, 1no. store name fascia sign, 7no. wall/fence mounted information signs, 5no. post mounted information signs, 3no. banner sign and 1 no. illuminated totem sign

Location: Railway Hotel, 1 Station Road, Parbold Grid Ref: SD 349079 41071

The Parish Council continues to object to this proposal with regard to illuminated signs facing residential properties and the height and style of the illuminated totem sign.

15. Update on Councillor raised issues

- The manhole between Christ Church car park and Parbold Hill pavement has clean water spilling out from it. This has been reported online and County Councillor Rob Bailey will be asked to intervene if it is not attended to shortly.
- Borough Councillor May Blake has been approached by residents asking for a street light to be installed on the pathway between The Common and Fairhurst Drive opposite the shop parade. The ground is uneven and difficult to negotiate after dark. There are no clear indications as to whom this land belongs. C.Cllr Rob Bailey had suggested that it may belong to the Dentist Surgery next to the path. It was confirmed at the meeting that both the County and Borough Councils both state that the path is not their responsibility. It was agreed that the Parish Council will pursue the residents' request.

• The issue of dog fouling around the village was again raised and it was resolved to include a reminder in the next newsletter.

16. Councillors' agenda items for future meetings

- Enquiries have been made to the Council regarding the ownership of some green areas within estates in Parbold. Whilst enquiries are ongoing it is worth noting that it is in everybody's best interest to keep these spaces as neat and clean as possible, particularly as the Best Kept Village judging will commence soon.
- A suggestion has been made to celebrate the Queen's Platinum Jubilee by creating another commemorative stone for the Jubilee Gardens. Research into this will be undertaken before the next meeting.
- The Parish Council was made aware of Jubilee events being organised by local businesses and organisations and whilst being unable to provide financial support to all concerned the Council is pleased to see such community involvement.
- The Council's insurance policy is due for renewal and enquiries will be made as to whether the quoted premium is index linked or whether a full reinstatement valuation is required.
- It was stated that the area directly in front of the bench in the Village Hall play area becomes muddy in inclement weather and a suggestion was made to improve the surface.

Pursuant to section 1(2) of the Public Bodies (Admission to Meetings) Act 1960 it is resolved that, because of the confidential nature of the business to be transacted (contracts for services, legal settlements and terms & conditions of employment), the public and the press leave the meeting during consideration of the remaining items on the agenda
